**Up to \$2,500 Reward Offered for Information  
Leading to Arrest of Robbery Suspect**

**Fort Wright, KY – July 10, 2014** – The Fort Wright Police Department, Kenova, West Virginia Police Department and Crime Stoppers are offering a cash reward of up to \$2,500 for information leading to the arrest of the suspect(s) believed to be responsible for two pharmacy robberies that occurred at a Walgreens Pharmacy located at 1825 Dixie Highway, Fort Wright, KY 41011 and at CVS Pharmacy located at 1405 Oak Street, Kenova, WV 25530.

The cash reward is donated by RxPATROL<sup>®</sup>, a collaborative effort between industry, pharmacists and law enforcement to collect, collate, analyze and disseminate information on pharmacy theft. **Robbery Details for Public Announcement:**

The Fort Wright Police Department and Kenova Police Department are investigating two pharmacy robberies that appear to have similar M.O.'s. Crime Stoppers and law enforcement officials are asking for the public's assistance by offering a reward of up to \$2,500 for any information that will help solve this crime. The reward is donated by RxPATROL.

- **Location:** CVS, 1405 Oak Street, Kenova, WV 25530

**Robbery #2 Details**

- **Date/Time:** Thursday, July 10, 2014 at approx.: 11:18am
- **Location:** Walgreen's Pharmacy, 1825 Dixie Highway, Fort Wright, KY 41011
- **Description of Events:** Suspect entered store proceeded to the pharmacy counter and passed a note to the pharmacist. The note stated that he was armed (not displayed) and demanded prescription medication. After the pharmacist complied the suspect fled the store and was seen fleeing the area in a white vehicle.
- **Suspect Description:** White, male, approx. 6' 190-195lbs wearing dark sunglasses and a dark colored ball cap, long sleeve, collared shirt over a black t-shirt, khaki shirt unbuttoned and sleeves rolled up. Tattoos on arms. Traveling in a white vehicle.
